ORDER**Sub:- Adoption of Broadband interconnection Combo Plan of Bharat Sanchar Nigam Limited**

The Co-ordination Committee in its 143rd Meeting held on 1st October 2010 accorded approval to provide an option of Broadband connection Combo Plan of M/s Bharat Sanchar Nigam Limited (BSNL) to the officers entitled for landline telephone facility at residences subject to the following conditions and categorization:-

<u>Category</u>	<u>Entitlement</u>
Category 'A'	
i) S.E. and equivalent & above including Addl. S.P. (Vig.) & Company Secretary	Broadband connection Combo Plan Rs. 749/- Per month + applicable taxes.
Category 'B'	
ii) Officers other than category 'A' above, who are entitled for Landline Telephone facility on their residence as per norms covered vide order No. 2272 dated 27.07.02.	Broadband Combo Plan Rs. 500/- Per Month + applicable taxes.
iii) Rebate of 20% on aforesaid amount for Government /PSU employees is allowed by BSNL and the same be availed invariably.	

Accordingly, the Broadband connection Combo Plan of M/s Bharat Sanchar Nigam Limited (BSNL) to the officers at the landline telephone provided at their residence is hereby adopted in Jaipur Discom on the following terms and conditions:-

- 1 Adoption of aforesaid Broadband Interconnection Combo Plan of Bharat Sanchar Nigam limited will be optional for the officers of the Nigam who have been provided with landline telephone facility at their residence. The officers concerned may either opt for Combo Plan as per their categorization or may continue under the existing scheme.
- 2 Only officers entitled for telephone at residence as per the prevailing norms of the Nigam can avail the aforesaid scheme.

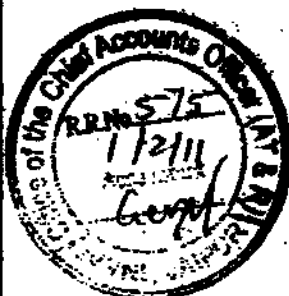
- 3 There will be only two categories i.e. A & B for the purpose of availing the Combo Plan.
- 4 Rs. 199/149/99 plan of BSNL including free local calls applicable on the Landline numbers will be dispensed with while availing the Combo Plan.
- 5 Officers having other broadband facility like Data cards etc. will not be entitled for the Combo scheme.
- 6 The cost on account of instrument i.e. Modem and broadband installation charges will be borne by the officers concerned.
- 7 Rebate of 20% has been allowed by the BSNL for Government/PSU employees. The company should avail the aforesaid rebate invariably.
- 8 The sanctioning authority for the purpose of accepting option for Broadband Combo Plan is as under:
 - a) For the officers of whom salary is preferred by AO/AAO (EA) Respective HOD/Functional Head
 - b) For other Officers Respective Chief Engineer/Dy. C.E
- 9 The concerned officer may even avail a better plan from BSNL on the condition that he will have to bear the additional amount beyond prescribed ceiling at his own.
- 10 The concerned Head of Office will ensure that no payment is made by the Nigam on account of Modem & installation charges etc.
- 11 The said facility may also be availed by the officers who are claiming reimbursement of telephone installed at their residence and being used for official purpose with the concurrence of the sanctioning authority, subject to the same terms and conditions.
- 12 As usual, the bills shall be preferred by the respective Head of Office and will be sent to circle AO for pre-auditing & after ensuring that Nigam has not to make any payment beyond prescribed ceiling will send the bills to cash section for arranging payment.
