ORDER

Sub:- Amendment in the qualification for Direct recruitment for the post of AEN (E&M).

Pursuant to the Co-ordination Committee decision taken in its 124th meeting held on 11.02.09, it is hereby ordered to amend the qualification for Direct Recruitment to the post of AEN (E&M) as under:

<p>Candidate possessing 70% marks in B.E.(Electrical) or 60% marks in AMIE (Electrical).</p> <p>Note:- Relaxation of 10% marks to SC/ST and in service regular employees of company of all categories and a relaxation of 5% marks to OBC candidates will be allowed.</p> <p>Above relaxation in the marks is not cumulative, meaning thereby that candidates will be allowed the relaxation in any one of the above provision for the maximum relaxation but will not be allowed the relaxation by adding more than one provision.</p>	<p>Candidates possessing 60% marks in Engineering degree (Electrical) or any other qualification declared equivalent to it.</p> <p>A candidate appearing in final year examination may also apply but he will have to acquire the requisite minimum qualification by the date of appointment.</p>	<p>Candidate possessing 70% marks in B.E. (Electrical) or 60% marks in AMIE (Electrical).</p> <p>The candidate whose result of final year examination of B.E./AMIE is awaited and having 70% /60% marks up to last but final year examination/ semesters of BE/AMIE (as the case may be) may also apply subject to condition that the final year result is declared before interview and marks obtained are 70% and above in case of B.E & 60% and above in case of AMIE.</p> <p>Note:-Relaxation of 10% marks to SC/ST and in service regular employees of company of all categories and relaxation of 5% marks to OBC candidates will be allowed.</p> <p>Above relaxation in the marks is not cumulative, meaning thereby that candidates will be allowed the relaxation in any one of the above provision for the maximum relaxation but will not be allowed the relaxation by adding more than one provision.</p>
