

**Clarification dated 6.8.09 on submission of Bid security Bank Guarantee  
on account of Bank Strike**

Certain bidders have requested this office to extend the opening date of this bid as they are not able to submit bid security Bank Guarantee with the bid due to bank strike on 6<sup>th</sup> and 7<sup>th</sup> August 2009. In this regard, it has been decided not to extend the due date of opening of bid.

However, JVVNL has decided to facilitate such bidders who fail to obtain the bank guarantee on account of Bank strike on 6<sup>th</sup> and 7<sup>th</sup> August 2009 that they can submit their bid till 1430 hrs on 7<sup>th</sup> August 2009 without the Bank Guarantee. It is also informed that the bid should be complete in all other respect except bank guarantee.

Those bidders submitting the bid without bank guarantee must submit an undertaking on the company letterhead in the enclosed format that they will submit the bid security bank guarantee of Rs. 20 Crores latest by 10<sup>th</sup> August 2009 till 1700 hrs, else their bid will be considered as "not submitted". This undertaking should be submitted to JVVNL separately in person along with the technical bid on or before 1430 hrs on 7<sup>th</sup> August 2009. In the main bid envelop it should be mentioned that the bid is without bank guarantee.

The bid without the undertaking or without bid security Bank guarantee will not be accepted.
