If the date of delivery in terms of clause given below falls in December, 2010, the applicable price of lead would be that as published by IEEMA as prevailing on 1st November, 2010 and the applicable All India Average Consumer Price Index Number will be for the month August, 2010.

Note 1 : The price of Lead ingots is the price of Pig Lead of 99.99% Pure as published by Hindustan Zinc Ltd. on their ex-smelter/ work basis. This price will be exclusive of ex- duty since MODVAT is available and exclusive of Sales tax and Octroi.

Note 2 : In a number of cases where a number of batteries are ordered simultaneously , the purchasers may insist on quoting F.O.R. Destination Prices. Since the price variation clause is applicable to ex-factory price (including packing, if any, required for rail/ road transport), the manufacturers are advised to indicate notional freight charges separately. The `PO' in such cases is price not of such notional freight charges.

- b) If the price variation formula is changed, the same shall be applicable for the price variation.   - (iii) When the material if offered ahead of delivery schedule on the request of Jaipur Vidyut Vitran Nigam Limited : Normally supplies ahead of delivery schedule shall not be accepted. However in case of urgency of material, if supplies are accepted ahead of delivery schedule, PV shall be allowed on the basis of the material is notified as being ready for inspection or date of receipt of inspection call in the office.
  - (iv) When the material is offered ahead of delivery schedule by firm at their own and accepted by Jaipur Vidyut Vitran Nigam Limited on the request of firm: Normally the request of the firm to accept the material ahead of delivery schedule will not be accepted. # **QUALIFICATION REQUIREMENT**

### **ITEM:- 110V-120 AMP. HOUR CAPACITY BATTERY SETS**

#### **TN- 2126**

The bidder should fulfill following qualifying requirements for successful participation in the tender along with relevant documentary evidence supporting each qualifying requirement without which the offer shall be considered non-responsive & rejected.

#### **1.0 STATUS OF BIDDER:-**

- a) The bidder should be a Manufacturer of offered items. The offers from sole selling agent/ authorized dealers shall not be entertained.
- b) Old/ New suppliers:- Any bidder located within or outside the state of Rajasthan has albeit participated for the first time in a particular Discom & meeting minimum qualification requirement (whether Rajasthan or outside Rajasthan) has supplied the tendered material/ higher rating in other utility shall be treated as an old supplier. Rajasthan based firms not meeting minimum quantity supplied criterion but having manufacturing and adequate testing facility and technical know how shall be considered as new firms and would be eligible for trial order only.

#### **2.0 PAST SUPPLY & PERFORMANCE CRITERIA :-**

The bidder shall meet both past supply and performance criteria as detailed below for opening of tenders:-

##### **2.01 PAST SUPPLY:-**

- 2.01.1 The bidder is required to quote for minimum 10% tendered quantity of tendered item, failing which their offer may be considered Non-Responsive.
- 2.01.2 The bidder should have designed, manufactured / fabricated, tested and supplied to utility / Discoms / Govt. Departments at least 2 X QQ (QQ being the quoted quantity) of similar item / higher rating of tendered material / equipment in last 3 financial years from the date of opening of technical-commercial bid.

**Note:** Requirement of quantity manufactured, minimum quantity to be offered and amount of Bank Guarantee to be furnished in absence of test certificate shall be reduced to 25% for Rajasthan based units.

- 2.01.3 In support of fulfillment of the past supply criteria, the bidder shall furnish documentary evidence in the form of certificate from Chartered Accountant in

the enclosed prescribed proforma only. This prescribed proforma should be furnished either in original or copy duly attested by Notary. The bidder shall also sign and affix seal on the C.A. Certificate. The **certificate should have membership number with the name & address of the chartered accountant.** Certificate should clearly indicate the quantity supplied, period of supply, etc. in the format prescribed, any deviation to format or information diverted format, will not be considered and rejected.

## 2.02 **PERFORMANCE CRITERIA:-**

2.02.1 i) If a bidder has supplied upto 50% of ordered quantity in previous tender upto date of opening of subsequent tender and scheduled delivery period expired, the bid of such bidder will not be opened in the Discom for that item.

ii) However, if the supplies have been completed for a quantity more than 50% but not completed upto date of opening of subsequent tender and scheduled delivery period expired, the quantity equal to the quantity pending in previous tender for that item shall be reduced from the subsequent tender quantity to be allocated to the bidder.

iii) If a bidder does not fulfill G.P. failed contractual obligations in previous tender(s) then quantity equal to the G.P. failed quantity pending for repair/ replacement shall be reduced from the subsequent new tender quantity for fresh item to be allocated to the bidder. This action will be in addition to the penal provisions applicable in respective tenders where supply is incomplete.

## 3.0 **TYPE TEST CRITERIA:-**

3.01 The bidder shall furnish valid and authenticated type test certificates from a Govt. approved / Govt. recognized / NABL Accredited laboratory / ILAC i.e. International Laboratory Accredited Laboratory (in case of foreign laboratory) of similar rating and design of tendered material/ equipment. Such type test certificates should not be older than 3 years as on the date of bid opening. For this purpose date of conducting type test will be considered.

The type test certificate by in house laboratory of tendering firm even if it is a Govt. approved / Govt. recognized / NABL accredited / ILAC accredited, shall not be accepted, in case of their own tender. This will not apply if tendering firm is Govt. company / public Sector undertaking.

3.02 The bidder should furnish documentary evidence in support of the laboratory whose type test have been furnished, that the said laboratory is a Govt. / a Govt. approved / a Govt. recognized / NABL accredited laboratory / ILAC accredited (in case of foreign laboratory).

3.03 The type test certificates shall be furnished either in original or copy duly attested by notary.

- 3.04 The bids of only those bidders shall be considered to be meeting the type test criteria who furnishes complete type test certificate with the bid as per above provision.

However, in the following cases the bid of the bidder may be considered meeting the type test criteria if the bidder furnishes an undertaking stating that valid type test certificate from a Govt. / Govt. approved / Govt. recognized / NABL accredited / ILAC accredited laboratory shall be furnished from first lot (without asking any delivery extension) along with bank guarantee with the technical bid from a Nationalized / Scheduled Bank in prescribed proforma at Schedule-III C or DD/ Pay Order amounting to Rs.5 Lac / Rs.1.5 Lac / Rs.0.5 Lac in case where the value of the purchase (corresponding to tendered quantity) under consideration is more than 1.5 Crore / upto 1.5 Crore/ Upto 0.5 Crore respectively. The initial validity of Bank Guarantee shall be nine months with claim period of three months in addition.

- i) A new Rajasthan based unit who does not possess valid type tests reports subject to technically competent.
- ii) Where one or more type tests) is/ are older than 3 years.
- iii) Where new type tests have been added in the specification.
- iv) Where some changes in respect of type test procedure of existing type tests have been introduced in the relevant standard.
- v) Where a new item is being purchased by Nigam for the first time.
- vi) The Rajasthan & outside Rajasthan firm who does not possess valid type tests certificates, if type test reports of higher rating are furnished.

#### **4.0 POOR RECORD OF PERFORMANCE AND DELIVERY :**

The bidder who have been black listed or with whom business relations have been severed in any of the state Discom shall not be considered. Severment of business relations will be done in case of following circumstances for the period and with the recovery mentioned against each :

i) When vendor does not accept order awarded on its accepted price and terms and conditions and does not comply with contractual formalities.	Forfeiture of EMD/cancellation of vendor registration to recover amount of EMD along with severment of business relations for three years from the date of issue of order.
ii) When vendor complies with contractual formalities but does not commence supplies.	Levy of maximum recovery on account of delay in delivery along with severment of relations for a period of 2 years from the date of issue of order or in next two bids whichever is later along with forfeiture of EMD / cancellation of vendor registration.

#### **5.0 Black Listing:**

Bids of the firms black listed shall not be opened. Bidder are liable for black listing for five years in any of the following circumstances ;

- i) There are sufficient and strong reasons to believe that the supplier or his employee has been guilty of malpractices such as bribery, corruption, fraud, vitiating fair under process including substitution of or interpolation in bids, pilfering or unauthorized use or disposal of NIGAM's material issued for specific works etc.
- ii) The supplier continuously refuses to pay Nigam dues after registered notice even after lapse of six months without showing adequate reasons and where the registering authority is satisfied that no reasonable disputes attracting reference to settlement committee or court of law exist for the supplier's action.
- iii) Where a supplier or his partner or his representative has been convicted by a court of law for offences involving moral turpitude in relation to the business dealings or where security considerations including suspected disloyalty to the Nigam so warrant.
- iv) If a registered supplier being non-renderer for supply but still submits applications giving his offer after receipt / opening of bids received after due process.

NOTE : 1.If a supplier after having tendered for a work / supply or after negotiations acceptance of order gives applications voluntarily vitating the fair bidding process, it shall also tantamount to malpractice.

NOTE: II. Severment once done will continue for the notified period of debarment even if the dues are deposited prior to the expiry of such severment period.

However, the relations be deemed to have been restored after expiry of severment period mentioned in the order but the bid of such bidder will not be opened in that Discom where severment was done if the recoverable amount has not been deposited by the firm i.e. severment done by one Discom for non-supply and corresponding recovery will not be effective in other Discom after expiry of notified period but the bid of such bidder will not be opened in that particular discom if the firm has not deposited amount recoverable.

## **6.0 APPEALS AND APPLICATIONS :**

Appeal against the order of black listing, debarment and severment can be filed before BOD. The BOD may reduced or waive the penalty if sufficient reasons / supporting documents are furnished by a supplier.

### **GENERAL CONDITIONS : - (ALL CONDITIONS BE DULY SIGNED & SEALED)**

- I) The bidder shall clearly indicate the deviations such as 'Technical Deviation & Commercial Deviations' in the prescribed proforma only. The deviations indicated elsewhere in the bid shall not be accepted.
- II) The bidder must clearly fill up each and every particular of guaranteed technical particulars annexed with Technical Specifications otherwise he will be responsible for Technical Non-responsiveness.

- III) All documents required in the prescribed format are to be furnished along with the bid itself only except an attested copy of BIS licence (wherever it is required), failing which the bid will be summarily rejected.
  
- IV) However, a copy of BIS Licence may be submitted by the bidder upto the official working hours of one working day prior to the schedule / notified date of opening of price bid.
