SCHEDULE-III -A**PRE-QUALIFICATION REQUIREMENT**

The bidder should fulfill following qualification requirements for successful participating in the bid along with relevant documentary evidence supporting each qualifying requirement without which the offer shall be considered non responsive & rejected.

1.0 Status of bidder:

a) The bidder should be manufacturer of offered item. The offers from authorized dealer/ sole selling agent/sole distributor shall not be entertained.

b) Old / new Suppliers:- Any bidder having their works located within or outside the state of Rajasthan has albeit participated for the first time in particular Discom & meeting minimum qualification requirement (whether Raj. Or outside Rajasthan) has supplied the bided material / higher rating in other utility shall be treated as an old Supplier. Rajasthan based firms not meeting minimum quantity supplied criterion but having manufacturing and adequate testing facility and technical know-how shall be considered as new firms and would be eligible for trial order only.

2.0 Past supply and performance criteria:

The bidder shall meet both past supply and performance criteria as detailed below for opening of bids.

a) The bidder is required to quote for minimum 10% of bided quantity, failing which the offer may be considered non responsive.

b) The bidder should have designed, manufactured/fabricated, tested and supplied to utility/ Discoms/ Govt. Departments at least 2xQQ/ (QQ being the quoted quantity) of similar item / higher rating of bided material / equipment in last three financial years from the date of opening of technical- commercial bid. **Material supplied under Turnkey Projects shall be considered for qualifying requirement if bidder either furnishes a certificate of the Discoms / Utility that same material / equipment has been supplied to them or furnishes proof of supply i.e. receipted challans of the material / equipment supplied to Discoms / Utility.**

Note: Requirement of quantity manufactured, minimum quantity to be offered and amount of Bank Guarantee to be furnished in absence of test certificates shall be reduced to 25% for Rajasthan based units.

In support of fulfillment of the past supply criteria, the bidder shall furnish documentary evidence in the form of certificate from C.A. in the prescribed proforma only. This prescribed proforma should be either in original or copy duly attested by the Notary. The bidder shall also sign and affix seal on the prescribed format C.A. Certificate. **The certificate should have membership number with the name and address of the chartered accountant.** Certificate should clearly indicate the quantity supplied, period

of supply in the format prescribed. Any deviation to format for information diverted format will not be considered & rejected.

3. PERFORMANCE CRITERIA

(i) If a bidder could supply upto 50% of ordered quantity in previous bid upto date of opening of subsequent bid and scheduled delivery period expired, the bid of such bidder will not be opened in the Discom for that item.

(ii) However, if the supplies have been completed for a quantity more than 50% but not completed upto date of opening of subsequent bid and scheduled delivery period expired, then quantity equal to the quantity pending in previous bid for that item shall be reduced from the subsequent bid quantity to be allocated to the bidder.

iii) If a bidder doesn't fulfill G.P. failed contractual obligations in previous bid(s), then quantity equal to the G.P. failed quantity pending for repair/ replacement shall be reduced from the subsequent new bid quantity for fresh item to be allocated to the bidder. This action will be in addition to the penal provisions applicable in respective bids where supply is incomplete.

4. TYPE TEST CRITERIA:-

a) The bidder shall furnish valid and authenticated type test certificate from a Govt. approved/ a Govt. recognized/ NABL accredited laboratory/ ILAC i.e. International Laboratory Accredited laboratory / ILAC i.e International Laboratory Accrediation Cooperation (In case of foreign laboratory) of 33 KV Pin . Such type test certificates should not be older than three years as on the date of bid opening. For this purpose date of conduction Type Test(s) will be considered.

b) The type test certificates by in house laboratory of bidding firm even if it is a Govt approved/ Govt recognized/ NABL accredited/ ILAC accredited, shall not be accepted, in case of their own bid. This will not apply if bidding firm is Govt. Company/ Public Sector Undertaking.

c) The bidder should furnish documentary evidence in support of the laboratory whose type test have been furnished, that the said laboratory is a Govt/ a Govt. approved/ a Govt. recognized/ NABL accredited laboratory/ ILAC accredited (in case of foreign laboratory)

d) The type test certificates shall be furnished either in original or duly attested by notary.

e) The bids of only those bidders shall be considered to be meeting the type test criteria who furnishes complete type test certificates with the bid as per above provision.

f) However, in the following cases the bid of the bidder may be considered meeting the type test criteria if the bidder furnishes an undertaking stating that valid type test certificates from a Govt/ a Govt. approved/ a Govt. recognized/ NABL accredited laboratory/ ILAC accredited shall be furnished from first lot (without asking for any

delivery extension) along with Bank Guarantee, with the technical bid from a Nationalized/ Scheduled Bank in prescribed proforma at Schedule-III C or DD/ Pay order amounting **Rs. 1.5 Lac.** The initial validity of BG shall be 9 months with claim period of 3 months in addition

- i) Where a new Rajasthan based firm is participating & is technically competent.
- ii) Where one or more type test(s) is/ are older than 3 years.
- iii) Where Rajasthan/outside Rajasthan firm furnishes requisite type test reports of higher rating material.

5. POOR RECORD OF PERFORMANCE AND DELIVERY

The bidders who have been black listed or with whom business relations have been severed in any of the State Discom shall not be considered. Severment of business relations will be done in case of following circumstances for the period and with the recovery mentioned against each.

(i) When vendor does not accept order awarded on its accepted prices and terms and conditions and does not comply with contractual formalities	Forfeiture of EMD/cancellation of vendor registration to recover amount of EMD alongwith severment of business relations for three years from the date of issue of order.
ii) When vendor complies with contractual formalities but does not commence supplies	Levy of maximum recovery on account of delay in delivery alongwith severment of relation for a period of two years from the date of issue of order or in next two bids whichever is later alongwith forfeiture of EMD/cancellation of vendor registration.

5. BLACK LISTING

Bids of the firms black listed shall not be opened. Bidders are liable for black listing for 5 years in any of the following circumstances:-

- i) There are sufficient and strong reasons to believe that the supplier or his employee has been guilty of malpractices such as bribery, corruption, fraud, vitiating fair under process including substitution of or interpolation in bids, pilfering or unauthorized use or disposal of Nigam's material issued for specific works etc.
- ii) The supplier continuously refuses to pay Nigam dues after registered notice even after lapse of six months without showing adequate reasons and where the registering authority is satisfied that no reasonable dispute attracting reference to Settlement Committee or Court of Law exists for the supplier's action.
- iii) Where a supplier or his partner or his representative has been convicted by a Court of Law for offences involving moral turpitude in relation to the business dealings or where security considerations including suspected disloyalty to the Nigam so warrant.

iv) If a registered supplier, being non-renderer for supply but still submits applications giving his offer after receipt/ opening of bids received after due process.

Note:-

- 1. If a supplier after having bided for a work/ supply or after negotiations acceptance of order gives applications voluntarily vitiating the fair bidding process, it shall also tantamount to malpractice.**
- 2. Severment once done will continue for the notified period of debarment even if the dues are deposited prior to the expiry of such severment period.**

However, the relations be deemed to have been restored after expiry of severment period mentioned in the order but the bid of such bidder will not be opened in that Discom where severment was done if the recoverable amount has not been deposited by the firm i.e. severment done by one Discom for non supply and corresponding recovery will not be effective in other Discom after expiry of notified period but the bid of such bidder will not be opened in that particular Discom if the firm has not deposited amount recoverable.

APPEALS AND APPLICATIONS:

Appeal against the order of blacklisting, debarment and severment can be filed before BOD. The BOD may reduce or wave the penalty if sufficient reasons/ supporting documents are furnished by the supplier.

GENERAL CONDITIONS:- (ALL CONDITIONS BE DULY SIGNED & SEALED)

- i) The bidder shall clearly indicate the deviations such as Technical Deviation & Commercial Deviations in the prescribed proforma only. The deviations indicated elsewhere in the bid shall not be accepted.
- ii) The bidder must clearly fill up each and every particular of Guaranteed Technical Particulars annexed with Technical Specification otherwise he will be responsible for Technical Non-Responsiveness
- iii) "All documents required in the prescribed format are to be furnished along with the bid itself only except an attested copy of BIS license (wherever it is required), failing which the bid will summarily rejected.
